Security Changes

Subject: Reset Your VSC and 72A Passwords Now

The new security changes have successfully been deployed for Vendor Support Center (VSC) Portal, eBuy, Advantage Spend Analysis Program (ASAP), Schedule Input Program (SIP), Reverse Auctions and 72A Industrial Funding Fee (IFF) Reporting.

For 72A users, please visit <u>72a.gsa.gov</u> to reset your password. VSC users, please visit <u>https://vsc.gsa.gov/FAS</u> to reset your password and it will be synchronized with eBuy, ASAP, SIP and Reverse Auctions. Please be aware that you will not be able to conduct business in these synchronized systems until your VSC password has been reset.

- 72a (Old)
 - Quarterly & Aggregated Sales by SIN
- Which are you?
 - tdr.gsa.gov
 - Contractor Login > Accept > See your Contract Number?



Order-Level Materials (OLM)

- Schedules Effected:
 - 03FAC, 56, 70, 71, 84, 00CORP, 738X
- New SINs will appear soon
- Alternative to "Open Market" items on a Contract
- Special Ordering Procedures to follow (GSAR Clause 552.538-82)
 - Prices for OLMs are not established in the Schedule contract or BPA.
 - OLMs are established and acquired at the order level, and the ordering activity contracting officer is responsible for making the determination that prices for all OLMs are fair and reasonable.



SIP is Down

- Connection issues between everyone's software and the GSA Servers
- No GSA Advantage uploads currently
- Side door exists but not reliable



The SAM Mess

- Notarized Letter now required when you Create or Update your SAM registration
- Template can be downloaded from site, but I have one you can get also
- Sam.gov > "ALERT ... updated FAQs"
- New Login process coming June 29th

In December 2017 GSA announced the release of the <u>SSQ+ tool</u> which is in beta testing. The original SSQ contains sales that have been reported through the 72A portal. The SSQ+ tool includes both sales reports from 72A as well as the FAS Sales Reporting Portal. Use of the <u>SSQ</u>+ tool allows for a more complete view of the data.

Schedule Sales Quer

The **Schedule Sales Query (SSQ)** enables you to easily access the sales, business size and NAICS information reported by our Federal Supply Schedule Contractors. The report generator allows you to quickly select a preformatted report for the information you need. To facilitate the process, the thirteen formats were developed based on historically requested data. Some of the reports will instruct you to selected either a Schedule number, a Fiscal Year, a Contract number, or a Company name. Unsure about the Schedule or contract number for your report?? The <u>Schedules a-</u> Library is a valuable source of information, so click over if you need extra facts before selecting the report format.

Schedule Sales Query presents sales figures as reported to GSA by contractors. The reports are generated as quarterly reports for the current year and the past five fiscal years. The sales data reported here are updated as contractors' reports are received, but the data may not be up to date. The information on this site is used by GSA for contract administration and fee management. It is not the official source of sales data. This data should be used for informational purposes only.
